

## **ENVIRONMENTAL POLICY**

Canossa Events Srl is aware that the services it provides for the planning, organisation and management of motor races and motoring events may have an effect on the environment. It acknowledges the importance of safeguarding the proper handling and control of its environmental impact and of raising awareness among its personnel and business partners.

Consequently, our company has a policy in place defining the commitments and aims our company intends to pursue.

Canossa Events Srl is committed to:

- Safeguarding compliance with all current laws and regulations relating to the environment that apply to the company and to its environmental impact
- Understanding the internal and external surroundings (pertaining to environmental, economic, social, or regulatory issues, etc.) where the company operates so that it has the ability to identify the needs and expectations of interested parties and so pursue their satisfaction with continuity
- Promoting the know-how, awareness and involvement of all those operating for the company, informing them of the company's goals and involving people in their pursuit
- Offering all personnel opportunities and incentives by means of training, motivation and involvement, so they may pro-actively aid ongoing improvements to the Environmental Management System
- Searching continuously for appropriate and effective solutions, processes and methods of operation that will enable a technologically advanced approach, adopting standards made available by the latest technologies
- Preventing pollution by making efforts to minimise its impact on the environment
- Examining any potential effects on the environment of all its operations and of any new or planned developments to its services, monitoring, studying and optimising its consumption of energy resources
- Monitoring and improving, wherever possible, the performance of its policy for the environment with a particular focus on its production of waste and traffic
- Promoting communications in-house and to external stakeholders as regards its policy, objectives, programmes and performance relating to the environment, maintaining a close dialogue with the various parties involved (customers, employees, authorities, regulatory bodies, etc.)
- Raising awareness and promoting the involvement of its suppliers with regard to the use of sustainable resources, and opting for technologies and products with a low environmental impact, where possible. Requiring specific commitments to protect the environment
- Promoting awareness and the regular updating of all its employees with regard to the company's organisation, to technical issues and methods, to their role and responsibilities, and to the environmental impact of their activities
- Adopting procedures to safeguard the effective monitoring of risks and the ability to take prompt action in case of accidents or emergencies.



In order to pursue these objectives, the Management has implemented an Environmental Management System (EMS) pursuant to UNI EN ISO 14001:2015, enabling Canossa Events Srl to implement a comprehensive approach to the management of environmental issues, addressing them in a global, systematic, consistent, integrated manner and with the intention of achieving continuous improvement. This Environmental Management System defines the organisation, responsibilities, procedures and resources within the company, so as to ensure:

- The contents of the System are circulated, fully understood, and implemented effectively;
- The pre-determined objectives can be measured and their accomplishment may be verified;
- That ongoing improvement is possible.

In order to safeguard the implementation of this Environmental Policy and so develop and maintain the Environmental Management System, the Management is committed to coordinating the application of the contents of the Company's Operational Procedures and their adaptation to the needs of the organisation, to regulations, and technical developments.
